FAA Runway Safety Action Team Meeting

On February 25, 2009 a Runway Safety Team from the LA Regional office spent the afternoon at Watsonville Airport. They looked over the ramps, taxiways and runways. They were very complimentary to our Airport Manager, Don French for his management. They were impressed with the fencing which controls access to the airport and the co-operation between the Airport management, the pilots and FBO's.

That said, they left a lengthy list of items to be corrected or added. Taxiway "C", the 8-26 taxiway, needs repaving. Signage needs updating. The Inspectors were concerned about the bird hazard generated by the dumps south of the airport.

They intend to recheck at appropriate times to find what progress has been made. They stressed that their function was to make recommendations and track what happens to those recommendations not enforcement. Some of the items will require funding from the FAA and the team indicated they will help arrange this.

That evening they spoke at the Watsonville Pilots Association regular meeting. The focus was runway and ramp safety. Afterwards they answered questions about particular issues unique to Watsonville Airport. The team expressed satisfaction about the inspection and the turn-out of pilots at the WPA meeting in the evening. One member of the team said "Invite us back again soon"

Loran Among Proposed Budget Cuts By Sarah Brown

President Barack Obama's proposed budget for fiscal year 2010 calls for the decommissioning of loran-C, which could serve as a backup for GPS-based navigation in the future.

The decommissioning is part of a cost-cutting measure which the government claims will save \$190 million over five years. Today many pilots use GPS, but a few still utilize loran. There are currently a limited number of potential backups for GPS, loran being one of them.

If the decommissioning goes forward, it is unclear which systems will be available in the event of a GPS outage. Over the years, AOPA has cautioned the U.S. Coast Guard, which maintains loran, not to make a decommissioning decision until a comprehensive backup plan is in place. Questions remain about whether a backup is needed and if it could be loran.

COMING TO A THEATER NEAR YOU! A Pilot's Story due out in 2010

Will Hawkins will tell you that filmmaking and flying are two of his passions. So it was only natural that he and flying buddy Rico Sharqawi, the forces behind Wilco Films, would combine the two for a documentary about aviation.

Utilizing aerial footage and interviews with well-known aviation figures as well as regular Joe and Jane Pilots, the film aims to show the rest of the world that "aviation is an amazing thing that can take your life in some really amazing places," says Hawkins. "It can take you to the FBO where you're talking with people, but also to the international space station and beyond. It all starts with this thing called general aviation." Hawkins has been blogging and podcasting his aviation experiences since he first began learning to fly in 2006. Accordingly, he has been blogging about A Pilot's Story on his blog as well as for AOPA's Let's Go Flying. Photos and a trailer can be viewed on the film's Web site, and Hawkins also maintains a Facebook page and a Twitter account. A Pilot's Story is ready to begin shooting air-to-air footage, and the crew is traveling around the country to get interviews with pilots

"It's great to talk to California pilots," says Hawkins, "but I want to talk to Florida, Wisconsin, Wichita [pilots]—any pilot who has a good story and wants to share it with the world."

Airshow performer Julie Clark and Late Late Show host Craig Ferguson have been interviewed. Also on the list are Sean D. Tucker and Patty Wagstaff, Southwest Airlines' Capt. Kathy Jensen, John and Martha King of King Schools, Miles O' Brien, and more. Hawkins says he'll also be talking with representatives of groups that use aviation to help the world, including Angel Flight, Able Flight, Build a Plane, and Young Eagles. The goal is to get the film finished early in 2010 and release it at Sun 'n Fun, Hawkins says.

Some sponsors have been acquired, including Virgin America, Scheyden Eyeware, and Lightspeed. Contributions are welcome; see the Web site for details. Hawkins said he plans to give some of the proceeds of sales back to the aviation community.

Many local pilots and their airplanes are featured in this film.

Wings Registration Cheat Sheet

So you attended the recent Watsonville Pilot's Association (WPA) WINGs seminar and learned a lot. However, you forgot to register on-line at FAA Safety.Gov but you remember signing in before you left. How do you get credit?

This has happened to quite a few pilots and to assist you here's a "cheat sheet":

Remember it only works if you have a "profile" on FAA Safety.Gov. If you don't have a profile, why not sign up today!

- (1) Log on to FAA Safety.gov...
- (2) On the left hand side look for the Events/Seminars link; select it...
- (3) Now on the "Event Search" page enter the airport ID and check the "Only Past Events" box...
- (4) Select "Perform Search"...
- (5) Look at the bottom of the page (last entry)...
- (6) Mouse over the icons to the right (the red pen on paper is "Request Credit")...
- (7) You are now on the Validation page; you'll need to "Find a "Validator"
- (8) Pull down menu: Find = FAAST Reps; within=50; miles of = 95076....
- (9) You are looking for the FAAST Safety Rep who hosted the seminar...
- (10) Click submit!!

That's it. Easier than the engine out procedure on a twin! Well maybe?
