Watsonville Fly-In changed to Labor Day Weekend

After 45 years of flying the skies over the Pajaro Valley on Memorial Day weekend, the board of the Watsonville Fly In & Air Show has voted to break tradition and move the event to Labor Day weekend effective 2010.

After fighting fog for nine out of 10 years this past decade, "even the staunch traditionalists on the board decided that it was time to attempt a change," executive director Theo Wierdsma wrote in a press release. "Weather patterns tend to be more favorable to air shows like the one in Watsonville early September. Memorial Day 2009 was again cold and overcast, putting a damper on an otherwise superbly organized event. As a result the event barely broke even after the board met its obligations to the various charities that lent a helping hand." Wierdsma said the board hopes to use the additional time to raise more money to fund the popular air show.

The board is raffling off a private cabana on the flight line complete with tables, chairs, refrigerator, access to the food and refreshments at the VIP Flight Deck Club, and 20 general admission tickets for each day of the event, he said.

The package typically only goes to sponsors at the \$10,000 level. Raffle tickets sell at \$25 each, and the winning ticket will be drawn Aug. 1.

Another fundraising event is a repeat of what was done earlier - a 50/50 raffle - potentially offering a cash prize of \$5,000. The organization will sell tickets at \$100 each. The winning ticket will be pulled just before Christmas. The winner will share the proceeds with the Air Show on a 50/50 basis.

At the Air Show in May the winning ticket went to a supporter who two weeks prior to the show died in a plane crash. Tickets for either fundraiser can be purchased by contacting Theo Wierdsma, executive director, at P.O. Box 1001, Freedom, Ca. 95019.

Cal Pilots Annual Meeting

The annual Cal Pilots (CPA) meeting was Saturday October 10 at Hiller Museum at San Carlos. Watsonville Pilots Association was represented by board members Sarah Chauvet, Treasurer and Dan Chauvet, Asst. Sec. for Legal Affairs.

During the chapter reports, Sarah Chauvet invited all to the Watsonville Airport Open House on October 17th. She reminded them that this was the 20th anniversary of the Loma Prieta Earthquake. She thanked all that participated in the airlift that brought tons of supplies to Santa Cruz County. Additionally, she reported on the status of the lawsuit between the WPA (and others) vs the City of Watsonville. She thanked CPA for their support of the WPA legal fund and the publicity in the Airport Advocate, which resulted in contributions from around the state.

Dan Chauvet invited everyone to the Watsonville Regional Airport Promotion—PAC dinner, on November 7th. The importance of PACs was discussed.

The CPA meeting program was very informative. Sandi Sawa, Manager San Diego County Regional Airport Authority (16 airports), spoke about Airport Land Use Commissions and Airport Land Use Compatibility Plans. She is well informed on both and discussed airport safety, avoidance of noise problems, airspace protection, and overflight. Sandi outlined the purposes of ALUCs and Compatibility Plans, (1) to protect the public health, safety and welfare, (2) prevent the creation of new noise and safety problems, and (3) prevent encroachment around the airport.

On the agenda was the problem of locating and planning power generating plants around airports. They produce plumes of hot air that create windshear (severe turbulence) for arriving and departing aircraft. Blithe Airport has lost its FBO because of the dangerous plumes. It could be the end of that airport. It is another hazard that must be addressed in an airport land use plan (ALUP).
